Section 105 C
Schools of Choice
Application Information

1. Applications for the Section 105c Schools of Choice Program will be available at Quincy Community Schools during regular school hours. Application deadlines for Section 105c Schools of Choice program are listed on the Quincy Community Schools School of Choice Application form for each semester.
2. An application must be completed for each student (including siblings) wishing to participate in the Section 105c Schools of Choice Program.
3. The choice district may refuse to enroll a non-resident applicant if the applicant is, or has been within the preceding two years, suspended from another school; if the applicant has ever been expelled from another school; or if the applicant has ever been convicted of a felony.
4. As required by Section 388.1705c of the State School Aid Act, "In order for a district or intermediate district to enroll pursuant to this section a nonresident pupil who resides in a district located in a contiguous intermediate district and who is eligible for special education programs and services according to statute or rule, or who is a child with disabilities, as defined under the individuals with disabilities education act, Public Law 108-446, the enrolling district shall have a written agreement with the resident district of the pupil for the purpose of providing the pupil with a free appropriate public education. The written agreement shall include, but is not limited to, an agreement on the responsibility for the payment of the added costs of special education programs and services for the pupil. The written agreement shall address how the agreement shall be amended in the event of significant changes in the costs or level of special education programs or services required by the pupil." If the district and the applicant's resident district fail to reach a written agreement about the added costs of special education for a pupil enrolling in the district for the first time, the pupil will not be enrolled.
